Die Regulations governing the CAS and DAS Study Programs in International Law and Economics vom 26. Mai 2016 werden wie folgt geändert:

Subject

Art. 1 ¹ These regulations govern the Diploma of Advanced Studies in International Law and Economics with or without special qualification (DAS ILE), and the Certificate of Advanced Studies in International Law and Economics with or without special qualification (CAS ILE) within the framework of the general study program in international law and economics at the World Trade Institute (WTI).

Scope and Structure

Art. 6 ¹ DAS ILE with or without special qualification

The DAS ILE is a non-consecutive diploma of 30 ECTS. The DAS program consists of the following elements:

a Unverändert.

b Unverändert.

c Subject to the approval from the WTI and based on the student's area of focus, students may define an area of special qualification that will be defined in the diploma supplement given upon successful completion of the DAS program.

d The special qualification comprises coursework amounting to at least 10 ECTS credits.

² CAS ILE with or without special qualification

The CAS ILE is a non-consecutive certificate of 12 ECTS. The CAS program consists of the following elements:

a Unverändert.

- c Subject to the approval of the WTI and based on the student's area of focus, students may define an area of special qualification that will be recognized in the certificate supplement given upon successful completion of the CAS program. This also allows students to complete more than one CAS special qualification at the WTI with a different focus of study for each CAS completed.
- d The special qualification comprises coursework worth at least 4 ECTS credits.

³ The objectives of the special qualifications are defined in the study plan.

- b* Certificate of Advanced Studies in International Law and Economics with special qualification, University of Berne (CAS ILE Unibe). The certificate shall note the special qualification, as spelled out in the study plan.

³ The designations of the special qualifications in accordance with paragraph 2 letters a and b are specified in the study plan.


