The role

This is a postdoctoral research position in the project "Labor Standards Compliance and Buyer-Supplier Linkages in Global Supply Chains", funded by the Swiss National Science Foundation and jointly led by Professor Damian Raess (WTI) and Professor Matthew Amengual (University of Oxford). The postdoc will join a team and conduct research on the governance systems that have been created to monitor and improve labor standards in global supply chains.

Job description

The postdoc will be expected to undertake the following activities:

- Conduct academic research under the direction of Professor Damian Raess and under guidance of, and in collaboration with the PIs, Professors Damian Raess and Matthew Amengual, as well as in collaboration with other team members.
- Be responsible for data analysis, wrangling, and modeling. The key skill is the ability to extract and manipulate large sets of data to enable analysis of trade networks and labor standards.
- Contribute to the writing of academic papers and presentations.

Requirements

Essential

- Hold a Doctoral degree in Social Sciences (Political Science, Industrial Relations, Sociology, Development, Economics and Management)
- Competence in quantitative methods in the social sciences, including knowledge of statistical software (Stata and/or R)
- Ability to publish in leading social science journals, as demonstrated by publications in those journals or advanced working papers targeted at and suitable to those journals
- Fluency in English.

Desirable

- Any one (or several) of the following skills: a) knowledge of text analysis and data scraping (text to data); b) knowledge of the Orbis dataset and fuzzy matching; c) experience in using Wordscore and supervised machine learning algorithms
- Research interest in social movements.

Applicants must provide the following documents in a single PDF file: i) a letter of motivation; ii) a detailed CV (comprising the names of 2 academic references); iii) a writing sample (e.g., published or working paper); iv) transcripts and degrees of all university/college courses (if not issued in English, officially certified translations are required), including a supplement explaining the grading system; and (optionally) v) evidence of English proficiency through the submission of objective test scores such as TOEFL (100 or higher) and IELTS (7.0 or higher).
